#### **Bus Reform and Service Improvements in NSW**

The NSW Government's bus reform program now incorporates community consultation and regular service reviews into service planning. John has played a key role in the consultation and service review process. He has produced the consultation report following widespread surveying of each new contract service regions. This has involved compiling, cleansing and analysing data and stakeholder submissions to identify the key demands for modifications within each bus route. His work has enabled Ministry of Transport to respond promptly and offset negative media attention and public opinion backlash by providing rapid interpretative data relating to major bus network schedule and route changes.

John has also established a useable data resource for the North West Metro project team to communicate rapidly and effectively with interested industry groups and the public for the purpose of briefings and submissions.

John supports the community liaison team ensuring consultation and communication activities comply with community relations statutory reporting. His role includes development and ongoing maintenance of the community liaison database. He occasionally chairs the Community Liaison Group meetings and regularly takes the meeting notes along with generally assisting with community liaison. He is also responsible for the generation of regulatory reports and oversees complaint handling, dispute resolution and notification procedures.

Thomas Direct is one of the largest independent outbound marketing call centres in Australia. They were responsible for the fundraising activities of a number of charities including The Endeavour Foundation art union, RACQ Careflight and the Arthritis Foundation. Key Achievements

C & A Electronics was started in November 1986 and grew to become the major repairer in Australia of electronic control systems used in the operation of electric wheelchairs and scooters. As part of the operation the company was often called upon to develop specific solutions for mobility control that allowed disabled persons to interact with their work environment and achieve a greater degree of independence. These projects often involved development of sophisticated electronic systems that enhanced communications and allowed clients to manipulate their environment. The company also undertook service contracts and repair of medical diagnostic and monitoring systems used in hospital ICU's and Radiology practices. We also repaired and serviced industrial process control systems.

### **Diasonics (Australia) Pty Ltd 1986 -1983**

Role: Queensland Manager

Diasonics was a major American based innovator and supplier of Diagnostic Ultrasound Imaging and Digital Angiography technology worldwide. They were established in 26 countries and were one of the fastest expanding technology companies in the world during the 1980's. John successfully established a base of operations in Queensland achieving 150% growth for the company over 2 ½ years, the largest growth of all states in Australia.
